## LEAPFROG HOSPITAL “SAFETY” LIST TO BE RELEASED DECEMBER 7



As organizations evolve in healthcare, one of the most successful ones is **Leapfrog**, Washington DC, a nonprofit organization committed to driving quality, safety, and transparency in the U.S. health system. The Leapfrog Hospital Safety Grade assigns letter grades A - F to hospitals based on their record of patient safety, helping consumers protect themselves and their families from errors, injuries, accidents, and infections. Of the more than 2,600 hospitals graded, 832 earned an A grade, 662 earned a B. Over 93% of the hospitals achieved a C or better. Several states have made dramatic improvement over the years including Rhode Island, Maine, and Virginia, which carried the highest percentage of A hospitals among all states. Since the rankings began in 2012, Rhode Island and Wisconsin are two of the five states showing the most improvement. Rhode Island went from No. 50 in 2012 to the number No. 1 position in fall 2017. In the same time period, Wisconsin went from 44th position to 6th. Rhode Island had 7 hospitals rated by Leapfrog and Wisconsin 56. The entire list will be made public this Thursday.

## AMS CELEBRATES ITS FIFTIETH



The company celebrated its 50th anniversary with a dinner for the employees and their guests on Friday, November 17, 2017, at the Bancroft in Burlington, a “city chic” steakhouse in the suburbs. AMS took over the Warhol Room, named for the famous artist, which was a fitting scene for the tribute with the 1966 Warhol “Cow” lithographs covering one wall of the room. Given it was the Friday night before Thanksgiving, this was a great kick off to the holiday season. Photos from previous company events were displayed on easels to bring back memories, and many more pictures were taken that night. Employees lent their baby pictures for the evening, and they were displayed in the shape of a “five” and “zero” as people made guesses as to who was who. Formal remarks focused on providing some history of the first 30 years of the company when AMS operated in a different model than the current one.

The major impetus to AMS starting in 1967 had been the implementation of Medicare on July 1, 1966. At that time 18.9 million people were eligible for Medicare and 17.6 million voluntarily enrolled for supplemental coverage. This led to increased demands in the hospitals and strains on operations. The first AMS project in 1967 was a group nursing study of resources and staffing at several hospitals. Fifty years later, this project was one many would have easily guessed to be our first area of focus. Even when looking at the list of top concerns from 20 years ago in the article following, it is uncanny how little has changed.
